TeraMessage Mobile app – TeraChat – TeraKey USB

Privacy Policy

General

1. Canamex Communications Corporation and its subsidiary companies and affiliates ("Canamex") are committed to maintaining the privacy and security of your corporate mobile and server stored information.
2. Information is defined as sensitive or non-sensitive text messages, photographs, files and recorded voice messages sent and received using TeraMessage Mobile app in smartphones, TeraChat in computers, and while stored in your TeraCryption Private System server assigned to your corporation.
3. This Privacy Policy explains Canamex's practices with respect to the use, processing, communication, transfer, delivery, storage or disclosure of your corporate information, including handling of users' personal information. The application of this Privacy Policy remains subject to applicable laws including legislation, regulations and the orders of any courts or other lawful authorities, other lawful requests or legal processes.
4. Canamex provides the TeraCryption Private System only to corporations, organizations and institutions under a separate User License System Agreement.
5. The terms of this Privacy Policy apply to the use of TeraMessage Mobile app for iPhone and Android devices; TeraChat for communicating messages and files using computers; and TeraKey USB devices to encrypt any type of files for safe storage in computers and servers. These applications are part of the TeraCryption Private System.

Our Privacy Policy commitment

6. The TeraCryption Private System allows you and other users in your corporation to use TeraMessage Mobile app to send messages, take pictures and record voice messages for transmission to other authorized users.
7. This private information sent using TeraMessage Mobile app and TeraChat, can only be read, seen and heard by the recipients(s). The Administrator of your TeraCryption Private System determines who can send messages, files and voice messages to whom.

No one else can read, open files and listen to voice recording messages. This information is temporarily stored in the server protected by encryption.

8. The photographs taken using the TeraMessage Mobile app and files received from other users are not stored in the mobile device, achieving maximum privacy and security of mobile information.
9. Financial payment activities or government identification numbers being part of a message or a file sent and received using the TeraMessage Mobile app will never be publicly or privately disclosed by Canamex since Canamex does not have access to this sensitive encrypted information on the assigned TeraCryption customers' server. Therefore, Canamex shall not disclose any personal or sensitive user data related to financial or payment activities or any government identification numbers.
10. Canamex does not allow unauthorized publishing or disclosure of people's non-public contacts. Canamex does not have access to this encrypted information in the assigned TeraCryption customers' server.
11. Sensitive messages and files sent and received by the TeraMessage Mobile app are protected by end-to-end encryption. This data and information may be stored in assigned TeraCryption customers' server, but cannot be read by Canamex or by the Customer's service personnel because it remains protected by encryption at all times.
12. No one can decrypt stored TeraCryption private information in the TeraCryption server. Decryption is automatically performed only when the information is requested by the individual who sent or received it. Stored or sent TeraCryption encrypted information cannot be shared with anyone else unless it is sent by the sender to other recipients.
13. Messages, photographs, files and voice messages sent and received by the TeraMessage Mobile app cannot be disclosed by Canamex since Canamex does not have access to this information stored in the customer's private server or in the individual's TeraMessage Mobile app.

TeraCryption is a private secure system

14. Canamex provides the TeraCryption Private System only to corporations, organizations and institutions. Canamex does not provide the TeraCryption System to individuals of the general public.

Control who are the users in your corporate TeraCryption Private System

15. The Administrator of your TeraCryption Private System controls who belongs to your corporate system and who can communicate with whom.

Messages and files protected in transit

16. Messages, photographs, files and voice messages are protected in transit by encryption and can only be viewed by the sender and by the recipients.

Messages and files protect at rest

17. Determined by the TeraCryption Private System Administrator in your corporation, messages and files cannot be read at the TeraCryption server by Canamex and/or by the TeraCryption customers' server personnel. Messages and files are stored protected by high level encryption.

There is no need of telephone numbers

18. TeraCryption users do not need to provide their telephone number to belong to your corporate TeraCryption Private System, maintaining complete individual privacy and avoiding possible geo-location.

TeraMessage Mobile app for Android and Apple devices

19. The TeraMessage Mobile app has unique security features to protect messages and files received from other users. Messages can be deleted remotely if the

phone is reported lost. Each message can be automatically deleted in the TeraMessage Mobile app when programming the life of the messages stored on the mobile device.

Legal and acceptable Use

20. Your corporation, organization or institution, is responsible for determining who uses your TeraCryption Private System.

Your privacy

21. Canamex does not claim ownership of the information that you send, receive and store in your TeraCryption System. You must have the necessary legal rights to such information.

Canamex's rights

22. Canamex owns all copyrights, trademarks, domains, logos, trade secrets, patents, and other intellectual property rights associated with our TeraCryption Private Systems. You may not use Canamex's copyrights, trademarks, domains, logos, patents, and other intellectual property rights unless you have our express permission under a TeraCryption Private System Agreement.

TeraCryption System License Agreement

23. Under a TeraCryption Private System Agreement, Canamex grants your corporation, organization or institution, a limited, revocable, non-exclusive, non-sublicensable, and non-transferable license to use our TeraCryption Private System. The sole purpose of the System Agreement is to enable the use of our TeraCryption Private Systems in the manner permitted by the Service Agreement Terms. No licenses or rights are granted by implication or otherwise, except for the licenses and rights expressly granted to your corporation under the TeraCryption Private System agreement.
